2. To represent all Ion Life supplied product in an ethical and honest manner, making no false of misleading claims or bring the reputation of Ion Life products into disrepute.
3. To sell Ion Life supplied products at the recommended retail price as agreed upon in the pricing schedule and will not discount, inflate or diverge from the recommended retail price unless authorised to do so by an authorised officer of Ion Life.
4. As a separate legal entity to Ion Life, to hold Ion Life no way responsible for the debts, liabilities and activities of the Dealer.
5. That all guarantees or warranties, excluding the manufacturers warranty, offered to purchasers by the Dealer are the sole responsibility of the Dealer and in no way place any responsibility, liability or claim upon Ion Life.
6. To advise their customer that the cost of freight to Ion Life premises for any repairs necessary, under the warranty made by Ion life, be the final responsibility of the customer. Ion Life will pay for the return shipping.
7. That this agreement is for a period of Two (2) years and thereafter will automatically renew for each two (2) year period provided the agreement is upheld. Either party shall be entitled to termination of this agreement upon the default of

the other. Thirty (30) days written notice of intended termination of agreement to be provided if no default has occurred.

2. That the cost of servicing the manufacturer’s warranty, excluding the cost of return shipping, on Ion Life supplied products remain with Ion Life.
3. To keep all information regarding the Dealer and their business activities in the strictest confidence, neither sharing nor allowing to be shared any information regarding pricing, supply, marketing, personnel, customer information or any other information relating to the Dealer’s business activities unless authorized to do so by the Dealer.
4. That the Dealer as an independent distributor and a separate legal entity is in no way responsible for the debts, liabilities and activities of Ion Life.
5. That the Dealer may represent the Ion Life range of products under their own brand and trademark with no reference to the Ion Life name, logo, brand or trademark.
6. That the Dealer may establish agents and associates for the purpose of soliciting purchase orders for the Ion Life range of products in any location in the USA and Canada..
7. To supply said products to the Dealer while ever they continue to trade in said products, or hold USA distributorship rights for said products, and may not withhold supply of said products for any reason, other than if the Dealer has been determined to have breached this agreement by a relevant court of law or body of arbitration legally empowered under USA law to make such determination.
